This account and the tickets remaining in stock shall be shown to the inspecting officers with other connected records when demanded for verification. Full facilities shall be given to inspecting officers to check the correctness of the records by counting the number of spectators or the audience during any performance covered by this permit.
4. A return giving the total in respect of particulars prescribed in Form II appended to the Karnataka Entertainments Tax Rules, 1959, for [each and all events of entertainments] during the week from [Friday to Thursday] (both days inclusive) /each day shall be sent so as to reach the office of the Entertainments Tax Officer on [Saturday] immediately following/on the next working day at the latest. The Treasury receipt for the [amount of entertainments tax [x x x x x] paid [x x x x x] or a crossed cheque drawn in favour of the Entertainments Tax Officer for the amount of the tax due shall be attached to the return.

 [A correct and complete account of tickets printed, the tickets authenticated and the number of tickets issued for admission shall be maintained in Form II-C.]
