NOTIFICATION

In exercise of the powers under the proviso to sub-section (1) of Section 25 of the Karnataka Value Added Tax Act, 2003 read with clause (1) of Rule 4 of the Karnataka Value Added Tax Rules, 2005, it is hereby notified with effect from First day of June 2013 that every dealer liable to be registered under the said Act shall submit the application in Form VAT 1, electronically through internet in the website <http://ctax.kar.nic.in/> by entering the relevant details displayed in the system and shall upload on the said website specified above, the following documents in addition to the documents as specified in Form VAT 1 :-

- (1). Recent photograph of the proprietor, Kartha of Hindu Undivided Family, each partner, authorised person or Director / person authorised to sign the form VAT 1 in the case of a company, trust and society;
- (2). PAN Card of proprietor / all partners / directors / kartha of family / trustee / and of firm / business;
- (3). Identity proof of proprietor / all partners / directors / kartha of family / trustee Driving Licence / Voter id / Passport / Aadhar card / Gas bill (recent document) of all Partners.
- (4). Articles of memorandum and articles of Association in the case of a company / such other in the case of a trust, cooperative society, etc.
- (5). Certificate of incorporation issued by Registrar of Companies / Certificate of Registration issued by the District Registrar / Registrar of Firms or Societies whichever applicable

- (6) Bank account details (S/B or C/A) or copy of the updated pass book or Bank Statement.
- (7) Proof of business place and every additional place of business, Rent agreement / tax paid documents (own property) & other details
Rental Agreement / Lease Agreement in case of a rented building. This shall be accompanied by a electricity bill. In case of own building copy of the receipt of the property tax paid.
- (8) Proof of residence of proprietor / partners / directors / kartha of family / trustee / authorized person (in case of company / trust/ society, etc .
Rental Agreement / Lease Agreement in case of a rented building shall be accompanied by a electricity bill. In case of own building copy of the receipt of the property tax paid for latest period.
- (9) Domicile Certificate issued by the Revenue Authority certifying that the applicant (proprietor / partners / directors / kartha of family / trustee / authorized person (in case of company / trust/ society) is resident of the declared place of residence, if the residence is outside the State of Karnataka .
