
Preamble:

M/s.Maxwatt Turbines Pvt.Ltd., Plot No.113, Jigani Link Road, KIADB Indl. Area, Jigani, Anekal Taluk, Bengaluru-05, is a registered dealer borne on the files of this office vide TIN:29790351736. The dealer in his letter cited at reference above has intimated that C-form bearing No.KACA 1973751, dt:117/03/2011 for Rs.21,81,464/- which was issued to M/s. BDK Engg. Industries Ltd., Hubli has been lost while their custody .

Accordingly, they have made complaint to the jurisdictional police officer, executed indemnity bond in Form-G in favour Govt. as laid down under Rule 12(2) and 12(9) of the CST Act, 1956 and also produced paper cuttings for having published in two local papers and requested this office to issue duplicate C-Form and also to treat the above lost C-Form to be invalid. Hence this order.
