No. FD 115 CSL 2007 (12), Bangalore, dated 30th March, 2007

In exercise of the powers conferred by Section 8-A of the Karnataka Sales Tax Act, 1957 (Karnataka Act 25 of 1957), read with Section 21 of the Karnataka General Clauses Act, 1899 (Karnataka Act 3 of 1899) and in supersession of the notification No.FD 360 CSL 2005, dated 11th November, 2005 published in the Karnataka Gazette, (Extraordinary), dated 11th November, 2005, the Government of Karnataka hereby reduces with effect from the first day of April, 2007, the tax payable by a dealer under section 5 of the said Act on sale of diesel to an industrial unit (engaged in either manufacturing or processing) located in the State for use by such unit in its Captive Power Generation Set to four percent, subject to the condition that such dealer furnishes a declaration duly filled in and signed by the said industrial unit and counter signed by the officer of the jurisdictional Local VAT office or VAT Sub-office, in the form specified below along with the monthly statement to be filed by him.
