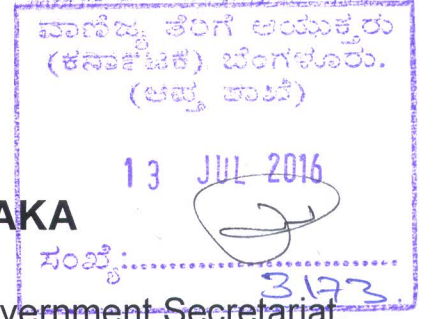

NOTIFICATION

In exercise of the powers conferred by sub-section (3) of Section 8-A of the Karnataka Sales Tax Act, 1957 (Karnataka Act 25 of 1957), the Government of Karnataka hereby amends with effect from the 12th July 2016, the Notification No.FD 50 CSL 2016, dated 19th May 2016, published in the Karnataka Gazette, Extraordinary, dated 20th May 2016, as follows.-

In the said Notification, for the words, figures and punctuation "as fixed under the Karnataka Cane (Purchase and Supply) Act, 2013 on or before 30th June 2016 and production of Clearance Certificate", the words, figures and punctuation "as fixed under the Karnataka Cane (Purchase and Supply) Act, 2013 on or before 31st July 2016 and production of Clearance Certificate" and for the words, figures and punctuation "VAT Division of the Department of Commercial Taxes, Government of Karnataka, on or before 30th June 2016.", the words, figures and punctuation "VAT Division of the Department of Commercial Taxes, Government of Karnataka, on or before 12th August 2016." and for the words, figures and punctuation "cleared dues of the farmers relating to the financial years of 2013-14, 2014-15 and 2015-16 as per

the Fair and Remunerative Price (FRP) fixed under Sugar (Control) Order, 1966 and the State Advisory Price (SAP) as fixed under the Karnataka Cane (Purchase and Supply) Act, 2013 on or before 30th June 2016.”, the words, figures and punctuation “cleared dues of the farmers relating to the financial years of 2013-14, 2014-15 and 2015-16 as per the Fair and Remunerative Price (FRP) fixed under Sugar (Control) Order, 1966 and the State Advisory Price (SAP) as fixed under the Karnataka Cane (Purchase and Supply) Act, 2013 on or before 31st July 2016.” shall be substituted.
