GST Act-2017 from the competent Authority and submit the payment challan before taking delivery of the goods. Said purchase will be treated as URD purchase.

10) **Successful bidder shall pay applicable GST On Bid price (Quoted price) separately to the concerned Head of Account.**

11) The undersigned after getting the approval from the competent Authority regarding highest bid quoted by the successful bidder, will give intimation to the successful bidder, he/she shall deposit the bid amount within **THREE DAYS** through RTGS/any on-line mode Payment to the Bank Account bearing Account No.110072134998 ( Canara Bank, Royal circle Branch, Ballari, IFSC Code: CNRB0010602 ) from the date of intimation. 14) EMD of the Unsuccessful bidder will be returned after completion of auction proceedings.
