**AUCTION NOTICE**

The Conveyance bearing No. KA-01-AG-0344 was intercepted by the undersigned i.e. Commercial Tax Officer, ENF-46, SZ, Bangalore on 04-05-2018 at 5.45 AM at Tumkur Road, Bengaluru while transporting mixed parcel from Mumbai to Bangalore. After verification of the goods & the documents, a Notice Dt.04-05-2018 was issued U/Sec.129(1) of the KGST & CGST Act,2017 proposing to levy tax & penalty for the goods not covered by valid & prescribed documents for transportation.

In response to the Notice Dt.04-05-2018, the transporter & the owners of certain goods paid the applicable tax & penalty and got the conveyance & goods released. But, neither the transporter nor the owners of certain goods paid the applicable tax & penalty. Hence, a Confiscation Order No. ADCOM/ENF/SZ/CTO/ENF-46/GCE-08/2018-19 Dt.19-05-2018 as provided U/Sec.130 of the CGST/KGST Act, 2017 was passed confiscating the goods described below :-
