

**INVITATION OF BIDS IN SEALED COVER FOR AUCTION OF KAMLA PASAND PAN
MASALA & KP DOUBLE BLACK ROYAL TOUCH PREMIUM CHEWING TOBACCO.**

Whereas 1,92,000 pouches of Kamla pasand Pan Masala & 3,84,000 pouches of K P double black royal touch premium chewing Tobacco has been confiscated by the undersigned U/s.130 of the KGST/CGST Act,2017 while transporting from Delhi to Bengaluru by evasion of taxes. For realization of tax, penalty and fine levied thereon, it is proposed to auction the said goods in 'as is where is condition' by way of bids in sealed cover basis, subject to the following condition.

- 1) The interested bidders shall inspect the goods lying in the office premises of this office on 26.10.2021 between 11-00 AM to 5-00 PM
- 2) The interested bidders shall submit the bids in a sealed cover to this office on or before 02.11.2021
- 3) The interested bidders shall deposit EMD amount of Rs.25,000-00 in the form of pay order/ DD drawn in favour of Commercial Tax Officer (Vigilance)-14, Bengaluru along with bids.
- 4) The bidders shall quote the basic amount for Rs.1,92,000 pouches of Kamla Pasand Pan Masala & 3,84,000 pouches of K P double black royal touch premium chewing Tobacco.
- 5) The bids shall be in accordance with the prevailing market price.
- 6) The bids in sealed cover will be opened on 06.11.2021 at 12-00 PM at this office in the presence of attending bidders, and if any bids acceptable, the successful bidder will be announced on the same day.
- 7) The successful bidder, in addition to the basic amount, shall pay the applicable KGST @14% and CGST @14% along with cess @ 60% for Kamla Pasand Pan Masala & cess 160% for KP double black royal premium chewing Tobacco on RCM basis.
- 8) The successful bidder shall make the payment electronically to the GST Account and shall take delivered of goods within 07 days. In case of failure, the EMD shall be forfeited.
- 9) The undersigned shall have the power to accept or reject any bids without adducing any reason.
