REVISED AUCTION NOTICE

In pursuance of the assignment No-1917/2018-19 dated 07-02-2019 issued by the Addl. Commissioner of Commercial Taxes (Enf), SZ, Bengaluru, the un-declared place of business (Go-down) situated at Sampangi Building, Sarjapur Main Road, Near Maruti Service Center, Indlubele, Bidarguppe, Attibele, Bengaluru-562 107 was inspected on 07-02-2019. Neither the owner of the goods Nor the Owner of the building has failed to furnish the valid documents for the goods stored in the above said go-down. Hence notice dated 18-03-2019 under section 122 & 130 Of CGST/SGST Act 2017 was issued and served on the Owner of the building and also affixed at the un-declared place of business (Go-down) on 18-03-2018. In response to the said notice neither the owner of the goods Nor the Owner of the building came forward to pay the penalty of Rs.12,05,280-00 U/s 122 of CGST/SGST Act 2017 and fine of Rs.9,33,120-00 U/s. 130 Of CGST/SGST Act 2017.Hence confiscation order was passed on 28-03-2019 for the confiscation of goods described below by the undersigned in accordance with the provisions of Section 130 of GST Act.2017. Accordingly, goods were confiscated. As neither the owner of the goods nor the Owner of the building came forward to pay the penalty and fine as per the orders passed. Hence, the said goods are proposed to be disposed of in the public auction as per section 130 of GST Act, 2017.
