

## General conditions for eligible auctions:

1. Auction proceedings to dispose the vehicle is through e-procurement portal only.
2. Initial price of the vehicle is Rs.70,000-00
3. The public who are interested to participate in the e-auction proceedings shall pay a deposit of Rs.7,000-00 through e-payment mode.
4. The public who are interested to inspect the vehicle before last date of e-auction may do so during the working days between 10.00 AM to 5.30 PM in this office.
5. The deposit amount will be returned immediately to unsuccessful bidders.
6. Successful bidder shall pay 25% of the amount of e-auction sales and taxes payable on such amount immediately. If the amount is not paid, the e-auction sales to the successful bidder will be cancelled without any notice and the initial deposit paid by him will be forfeited and remitted to the Government.
7. The successful bidder shall pay remaining 75% of the sales amount within 15 days from the date of permission of Commissioner of Commercial Taxes. After words he can shift the vehicle from its place on his own expenses.
8. If the successful bidder fails to take possession of the vehicle after making full payment of sales amount within the prescribed time. He shall pay Rs.50-00 per day rent for the ground where the vehicle is stationed.
9. The officials working in this department are not entitled to participate in the e-auction sales proceedings.
10. The decision of Addl. Commissioner of Commercial Taxes (Enf)-South Zone, Bangalore is final for any disputes.
11. Bidder shall upload the eligibility document and Annexure-1 application form
12. The Addl. Commissioner of Commercial Taxes (Enf)-South Zone, Bangalore is having power to accept, refuse, postpone or cancel the e-auction.
